SECTION 4 : FIRST AID MEASURES

SECTION 7 : HANDLING AND STORAGE

Requirements relating to storage premises apply to all facilities where the mixture is handled.

7.1. Precautions for safe handling

Always wash hands after handling.

Remove and wash contaminated clothing before re-using.

Remove contaminated clothing and protective equipment before entering eating areas.

Avoid contact with eyes.

No special precaution apart from the observance of hygiene rules

Fire prevention :

Handle in well-ventilated areas.

Prevent the formation of flammable or explosive concentrations in air and avoid vapor concentrations higher than the occupational exposure limits.

Never inhale this mixture.

Prevent the accumulation of electrostatic charges with connections to earth.

The mixture can become electrostatically charged : always earth during decanting operations. Wear antistatic shoes and clothing and floors should be electrically non-conductive.

Use the mixture in premises free of naked flames or other sources of ignition and ensure that electrical equipment is suitably protected.

Keep packages tightly closed and away from sources of heat, sparks and naked flames.

Do not use tools which may produce sparks. Do not smoke.

Prevent access by unauthorised personnel.

Take precautionary measures against static discharges by bonding and grounding equipment.

Store between 5°C and 40°C in a dry, well ventilated place.

Only use hydrocarbon-resistant containers, joints and pipes.

Storage

Keep out of reach of children.

Keep the container tightly closed in a dry, well-ventilated place. Keep away from food and drink, including those for animals. Keep away from all sources of ignition - do not smoke. Keep well away from all sources of ignition, heat and direct sunlight. Avoid accumulation of electrostatic charges.

Always keep in packaging made of an identical material to the original.

Appropriate engineering controls

Ensure adequate ventilation, if possible with extractor fans at work posts and appropriate general extraction.


